**POSSIBLE OUTCOMES**

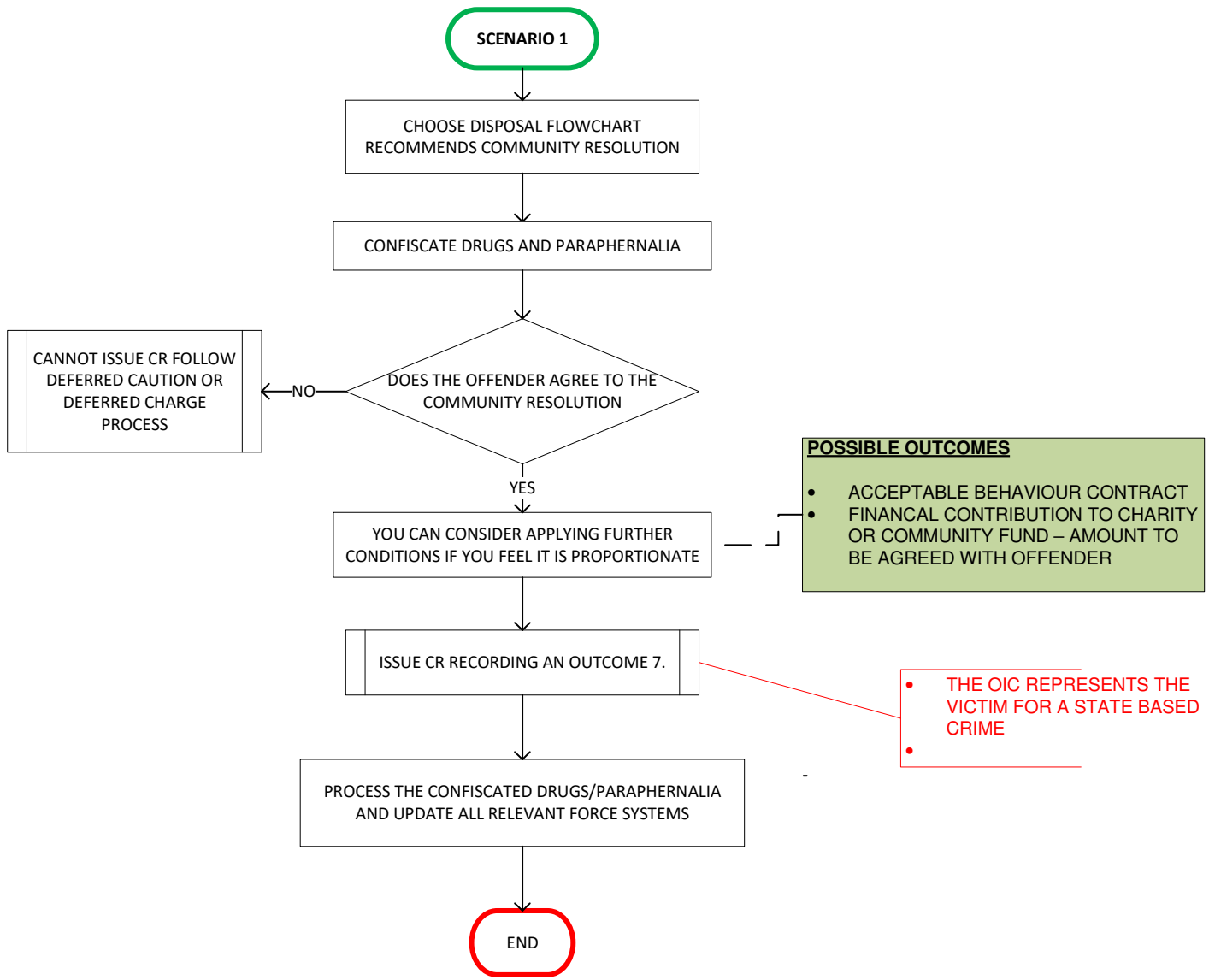
- ACCEPTABLE BEHAVIOUR CONTRACT
- FINANCIAL CONTRIBUTION TO CHARITY OR COMMUNITY FUND – AMOUNT TO BE AGREED WITH OFFENDER

ISSUE CR RECORDING AN OUTCOME 7.

- THE OIC REPRESENTS THE VICTIM FOR A STATE BASED CRIME

PROCESS THE CONFISCATED DRUGS/PARAPHERNALIA  
AND UPDATE ALL RELEVANT FORCE SYSTEMS

**SCENARIO 2**

CHOOSE DISPOSAL FLOWCHART  
RECOMMENDS DEFERRED CAUTION

CONFISCATE DRUGS AND PARAPHERNALIA

CARRY OUT ROADSIDE INTERVIEW –  
AND RECORD ADMISSION OF GUILT IN  
YOUR NOTEBOOK

• OFFENDER WILL NEED TO  
ATTEND A STATION AT A  
LATER DATE (WITHIN 60  
DAYS) TO SIGN THE  
DEFERRED CAUTION FORM  
OR BE ISSUED WITH THE  
SIMPLE CAUTION (IF NOT  
ELIGIBLE)

• GATEKEEPER TO  
RATIFY DECISION

OIC TO ISSUE A  
SIMPLE CAUTION

DOES THE OFFENDER MEET THE  
ELIGIBILITY CRITERIA FOR DEFERRED  
CAUTION

COMPLETE THE DEFERRED CAUTION FORM - YOU CAN CONSIDER  
APPLYING FURTHER CONDITIONS IF YOU FEEL IT IS  
PROPORTIONATE

**POSSIBLE OUTCOMES**

- RESTRICTIVE - LOCATION OR CONTACT BAN
- FINANCIAL CONTRIBUTION TO CHARITY OR COMMUNITY FUND – AMOUNT TO BE AGREED WITH OFFENDER
- UNPAID WORK FOR NO MORE THAN 20 HOURS

GATEKEEPER FOLLOWS REFERRAL TO  
PATHFINDER PROCESS

OIC SENDS COMPLETED AND SIGNED  
DEFERRED CAUTION TO PATHFINDER
